2012 TRIP POLICIES:

- **FULL REFUNDS** are only available if an email cancellation request is received 46 days prior to trip departure date.
- **CHECKS WILL BE CASHED 45 DAYS PRIOR TO TRIP:** We cash all checks about 45 days prior to each trip. There is a \$20 fee for any bounced checks.
- **CANCELLATION FEE:** If you cancel 45 days prior to a trip there is no cancellation fee. If you cancel 45 days or less prior to any Mammoth trip you will be charged a \$20 cancellation fee which is deducted from your refund. If you find your own replacement, or if we find you a replacement, you will still be charged the \$20 cancellation fee.
- **REPLACEMENTS:** If you find your own replacement, they must mail in their own trip form & check prior to the trip.
Singles: Your replacement must be of the same gender.
Couples: Both parties going on the trip must be OK with the original arrangements (i.e. sharing a bed/room).
- **NO REPLACEMENT:** If no replacement is found and there is no Wait List with an appropriate replacement, then you are responsible for the full amount of the trip. Remember, all checks are cashed 45 days prior to each trip.
- **TRIP CONFIRMATION:** You are responsible for checking the BCSC web site to confirm your spot.
